If the Applicant's unpaid balance exceeds the established credit line, the account may incur a fee and may be suspended and the Applicant's credit history may be reported to credit reporting agencies. Applicant's acceptance, signing, in whatever form, or use of any of the cards provided to the Applicant will constitute acceptance of the terms and conditions contained in the application and the account agreement. Applicant agrees that any liability arising or resulting from the misuse, unauthorized or fraudulent use, loss or theft of any of the cards issued to the company's account shall be fully borne, assumed and paid by the Applicant, until Martin is notified in writing of loss, theft, or unauthorized use, to the address listed herein, to the attention of Gold Star Administrator. If Martin uses an attorney or credit agency to collect an unpaid overdue amount, the Applicant agrees to pay reasonable attorney and/or collection fees. Applicant agrees that the account will be governed by Pennsylvania law.

- 1. Applicant/Card Holder agrees that the Martin Gold Star account is not a revolving credit card account and that any purchases made during the billing cycle are due and payable in full, including any applicable fees, upon receipt of the billing statement.
2. Applicant/Card Holder agrees that there is no liability to Martin Oil Company, any franchisee or licensee of Martin Oil Company, or any participating fuel retailer if, for any reason, the system should fail to dispense fuel.
3. Applicant/Card Holder agrees that the terms "Martin Oil Company" (a Pennsylvania Corporation), "Martin Gold Star Fuel Control System", "Martin Gold Star" and "Martin" are interchangeable in this document.

SAFETY

Applicant/Card Holder agrees to read and obey all SAFETY INSTRUCTIONS and abide by all current and future local, state, and federal codes pertaining to the dispensing and use of motor fuels, including but not limited to: STOP MOTOR; NO SMOKING; FILL ONLY APPROVED FUEL CONTAINERS; NO GAS IN GLASS; PORTABLE CONTAINERS MUST BE MARKED WITH THE NAME OF PRODUCT CONTAINED; DRIVER MUST STAY AT VEHICLE WHILE DISPENSING FUEL. In addition, to use Unattended Fueling Sites, Applicant/Card Holder agrees to undergo training at the site and follow posted operating instructions and safety procedures. Applicant/Card Holder must certify that their drivers/employees will note LOCATION of EMERGENCY INSTRUCTIONS IN CASE OF FIRE or PRODUCT SPILL; EMERGENCY CONTROL and SHUT-OFF SWITCHES; FIRE EXTINGUISHERS; and EMERGENCY PHONE or CALL BOX at each location before fueling. Drivers must REMAIN AT VEHICLES while dispensing fuel; and must not use cell or cordless phones at islands.

APPLICANT/CARD HOLDER and PERSONS AUTHORIZED BY APPLICANT/CARDHOLDER TO DISPENSE FUEL ARE RESPONSIBLE FOR FUEL SPILLS.

AGREEMENT TO TERMS

- 1. Applicant/Card Holder ("Applicant") has requested a credit account, if approved, and one or more charge cards from Martin Oil Company. 2. The undersigned Applicant represents that information given in this application is complete and correct and authorizes Martin Oil Company to check with credit references, credit reporting agencies, and other sources disclosed to confirm information given. 3. Applicant agrees to the terms and conditions set forth in this agreement, or provided with the cards, which may be amended from time to time. Use, by Applicant or others, of any card issued pursuant to this application, confirms Applicant's agreement to said terms and conditions. 4. Applicant agrees that in the event the account is not paid as agreed, Martin may report the undersigned liability for and the status of the account to credit bureaus and others who may lawfully receive such information.

ERRORS OR INQUIRIES

The Federal Fair Credit Billing Act requires prompt correction of billing mistakes. If you think your billing statement is wrong, or if you need more information about a transaction on your billing statement: 1. Do not write on the statement. On a separate sheet of paper, write the following: a. Your name, address and account number. b. A description of the error and an explanation (to the extent you can explain why you believe it is in error). If you need more information,

- describe the item you are not sure about. Do not send in your copy of an invoice or other document unless you have a duplicate copy for your records.
c. The dollar amount of the suspected error.
d. Any other information which you think will help us identify you or the reason for our complaint or inquiry.
2. Send your notice of statement error to: Martin Oil Company, 528 North First Street, Bellwood PA 16617. Write to us as soon as possible, and sign your letter. You may telephone, but doing so will not preserve your rights under this law.

BILLING PROCEDURE

At the time of each purchase, an invoice is generated. Shortly after the last day of the month, you will receive an itemized statement listing the date of each purchase, product, price, location, amount, and other information. Upon receipt of statement, payment is due by the date shown to Martin Gold Star Fuel Control System, at the address indicated. Should you require research on, or a copy of any invoice, we reserve the right to impose a charge for the service.

FINANCE CHARGE, SERVICE CHARGE and REBATES

Martin Gold Star Fuel Control System reserves the right to add or increase service charges at any time subject to 30 day notice to each Card Holder. A finance charge of 24% per year or 2% per month is currently being charge on all Business Account balances over 30 days past due. A finance charge of 18% per year or 1.5% per month is currently being charged on all Personal Account balances over 30 days. Accounts which do not consistently pay within established credit terms will not receive volume discounts or rebates. Late payment fees may apply. Rebates may be rescinded or adjusted at any time, without notice.

CARD USE and ACCEPTANCE SITES

Purchases on the Martin Gold Star Fuel Control System are restricted to those items you or Martin Oil Company specify, excluding lottery or money orders. Cards may not be used as debit cards, nor for cash advance or cash back. Your Martin Gold Star card is accepted at all Martin General Stores, Martin Gold Star locations, and other designated independent sites. Acceptance sites may change without notice.

CARD REJECTION and SUSPENSION of CHARGE PRIVILEGES

Should payment not be made according to terms, or should purchases exceed established credit limits or purchase parameters or should Applicant/Card Holder's representatives violate safety or other practices deemed important by Martin Oil Company, cards may be rejected at the time of purchase, and cards may be confiscated. Martin retains the sole right to make credit and use decisions related to card purchases. Cards remain the property of Martin Oil Company, and must be surrendered upon request.

CARDHOLDER'S UNLIMITED RESPONSIBILITY and NOTIFICATION OF LOST OR STOLEN CARD

Credit cards issued are the unlimited responsibility of the Card Holder until Martin Oil Company is notified in writing of loss, theft, or unauthorized use, to the address listed herein, to the attention of Martin Gold Star Administrator.
